Whereas, the General Assembly in 2018 duly passed HB 1456 and the Governor has duly signed this legislation, and

Whereas, this legislation per section 190.460 RSMo imposed a new statewide 3% tax on prepaid cell phones and plans, and

Whereas, this legislation permitted counties to opt out of both the tax imposed at retail and the right of a county 911 center to receive any of these funds back per 190.460.6 RSMo, and

Whereas, Department of Revenue issued an informal opinion that if a 911 Center or County were to opt in for the 3% tax such County/911 center would lose its 190.335 RSMo revenue on all retail items, and

Whereas, although this was an informal opinion, if valid the consequences to the sources of funding for the Christian County 911 Center would have been devastating, and

Whereas, therefore out of an abundance of caution the Christian County Commission voted to opt out of the statewide 3% tax on prepaid cell phones and plans per|190.460.6 RSMo, and

Whereas, in 2019 the General Assembly passed SB 291 and the Governor signed it, which in section 190.460.3 RSMo removed the ambiguity created by the Department of Revenue's informal opinion, and

Whereas, the Commission understands that this legislation appears to establish a deadline of November 15, 2019 within which to "opt back in" to the 3% tax on prepaid cellphones and plans per 190.460.7 RSMo, and

Wherefore, the Commission has approved the following action on behalf of Christian County.
