A quorum was established. Presiding Commissioner Phillips entertained a motion to approve all items listed on the consent agenda, which included approval of Christian County Commission's agenda for today, September 16th, 2019 as published, approval of Christian County Commission's regular session minutes from September 12th, 2019, approval of Christian County Commission's closed session minutes from September 10th, 2019, and the re-appointment of Robert Snook to the Christian County Senior Citizens Service Fund Board. Eastern Commissioner Robertson so moved. Western Commissioner Bilyeu seconded the motion.

Presiding Commissioner Phillips entertained a motion to remove Vehicles for Assessor's Office, as Assessor Gray is unable to attend today's meeting. Western Commissioner Bilyeu so moved. Eastern Commissioner Robertson seconded the motion.

The Commission met for Kloppe Phone Audit. Discussion was held. Presiding Commissioner Phillips entertained a motion, that at the advice of counsel and recommendation by Christian County Treasurer Karen Matthews, that Christian County enter into agreement with Kloppe Associates. Eastern Commissioner Robertson so moved. Western Commissioner Bilyeu seconded the motion.

The Commission met with presenters Prosecuting Attorney Amy Fite and Chief Juvenile Officer Perry Barnes in regards to secure offices. Attorney Fite passed out a memorandum, explaining the need for secure offices. The two offices are seeking to re-key offices/rooms so keys are unique, to limit access. Western Commissioner Bilyeu inquired as to whether or not this request was made previously, during initial planning for the Circuit Court Building? Attorney Fite and Officer Barnes both said they had indicated the need for secure offices. Western Commissioner Bilyeu also inquired if each office had funds available to fund this change, both offices confirmed they are able to pay for this change. Sheriff Brad Cole and Captain Koch both expressed concern that in the event of an emergency their staff would be limited accessing the needed area, stating they would not be held liable if damages to the specified rooms/offices occurred. Western Commissioner Bilyeu moved to grant approval for both offices to be re-keyed, contingent upon the common areas being accessible to Security. Eastern Commissioner Robertson seconded the motion.
