Dear Miranda,

The Ozark Special Road District will not proceed with the Riverbluff Road improvements at this time and would like to reallocate the funds to provide improvements to Smallin Road from the Riverbluff intersection east to Cardinal, approximately 1.7 miles.

The improvements will include pavement widening to 22' wide with 1' gravel shoulders on each side and a 2" asphalt cap with wedging. Construction costs for the proposed improvements are estimated to be \$330,000.00.

The intention is to complete the widening and overlay still this year.
