Presiding Commissioner Phillips entertained a motion to approve all items listed on the consent agenda, which included approval of Christian County Commission's agenda for today, October 24<sup>th</sup>, 2019 as published, and Christian County Commission's regular session minutes from October 21<sup>st</sup>, 2019 and Certified Court Order No. 10-24-2019-01. The Commission met with Purchasing Agent Krista Raleigh for a bid opening for Lightning Protection for the Circuit Court Building. One bid was received from A1 Electric Service Inc. for \$40,400.00. Ms. Raleigh said the bid would be reviewed by Maintenance Supervisor Richard Teague, as well as Auditor Amy Dent and they will return Monday, November 4<sup>th</sup>, 2019 for possible recommendation of award. No action was taken.

The Commission met with presenter Circuit Clerk Barb Stillings for the Salary Commission Meeting. The Salary Commission minutes are on file with the Christian County Clerk's office.

The Commission met with Highway Administrator Miranda Beadles and Spencer Jones with Great River Engineering for a bid opening for Riverside Bridge. Four bids were received: Phillips Hardy Inc. for \$2,675,747.87; Lehman Construction for \$2,834,690.21; Hartman Construction for \$2,533,558.00; and Crossland Heavy Contractors for \$2,965,883.13. The bids will be reviewed by Great River Engineering to ensure all supporting documentation is received and a recommendation of award will be made at a later date. No action was taken.
