AN ORDER AND RESOLUTION OF THE CHRISTIAN COUNTY COMMISSION AUTHORIZING WITHDRAWAL OF CHRISTIAN COUNTY, MISSOURI'S PARTICIPATION FROM MIDWEST PUBLIC RISK'S LIABILITY, PROPERTY DAMAGE, AND WORKERS' COMPENSATION COVERAGE FOR THE 2020-2021 POLICY YEAR

WHEREAS, Midwest Public Risk (MPR) is a not-for-profit corporation created for the purpose of providing a voluntary self-insured pool for municipalities, counties, and school districts for insurance, property damage, workers' compensation, and other insurance coverage areas; and

WHEREAS, Christian County, Missouri has been a Member of MPR since July 1, 2012; and

WHEREAS, MPR bylaws outlined in Section 5.8 require any member entity wishing to withdraw from participation in one or more of MPR's programs to provide notification to MPR within ninety (90) days of the beginning of a new policy year; and

WHEREAS, Christian County, Missouri recently solicited bids for property, liability, and workers' compensation insurance coverage commencing July 1, 2020, which will result in its withdrawal from MPR.

NOW, THEREFORE, on Motion duly made and seconded, the question was called and Commissioner Bilyeu voted "yes", and Presiding Commissioner Phillips voted "yes", (Commissioner Robertson was absent), for Christian County to withdraw from membership in Missouri Public Risks (MPR) liability, property damage, and workers' compensation insurance and all other insurance coverage of MPR.

IT IS RESOLVED AND ORDERED by the Christian County Commission as follows:

Section 1. The Christian County, Missouri Commission hereby authorizes the Presiding Commissioner to inform Midwest Public Risk (MPR) that Christian County is not renewing and is withdrawing from membership in MPR's liability, property damage, and workers' compensation insurance and all other insurance coverage.

Section 2. The effective date of Christian County's withdrawal from MPR's insurance coverage and other benefits programs shall be July 1, 2020.
