Christian County is requesting bids from landscape maintenance contractors to perform on-call described services for the County under an annual contract. Services required during the contract period will be requested through issuance of work orders. There is no guaranteed minimum amount of services to be ordered. The County reserves the right to supply any or all materials. The County reserves the right to award to more than one bidder, and may select several service providers to provide the requested services. This contract is for a one-year period, and Christian County has the option of renewing the agreement for two (2) additional one-year periods.

Location:	County-maintained buildings with locations throughout Christian County.

	planting of flower beds; pruning, removal and maintenance of trees; landscaping insect
