A quorum was established. Presiding Commissioner Phillips entertained a motion to approve the consent agenda, which included Christian County Commission's agenda for today, March 23rd, 2020 as published, minutes for Christian County Commission's cancelled meeting dated March 20th, 2020; an emergency purchase for the Justice Center's HVAC unit in the amount of \$2,656.00, and Highway Administrator Beadles' suggestion of approval of County wide emergency procurement of needed items such as sanitizer, thermometers, Lysol etc. Procedures will be drafted to included specifications including purchases not to exceed \$100.00 and require supervisor approval prior to purchase. The Commission met with Highway Administrator Miranda Beadles for a guardrail bid for the Common II road district. The Highway department will be piggybacking off Greene County's existing bid. The lowest quote was received from Highway Safety Solutions for \$5,300.00 In the event that this project goes over the \$6,000.00 threshold due to installation or possible issues it is being brought before the Commission. Presiding Commissioner Phillips entertained a motion to approve the bid for guardrail. Western Commissioner Bilyeu so moved. Presiding Commissioner Phillips seconded the motion.

The Commission met with Purchasing Agent Krista Raleigh for a bid opening of office supplies.
