

The Commission stood in recess until 10:50 a.m.



Presiding Commissioner Phillips entertained a motion to adopt the press release presented and that beginning at 12:01 a.m. on Monday, March 30th, 2020 County offices would be closed to the general public. Western Commissioner Bilyeu so moved. Eastern Commissioner Robertson seconded the motion.


