A quorum was established. One bid was received from Goins Construction for \$17,105.00 (materials & labor). They also included a bid for a metal roof for \$27,570.00. Mr. Teague stated that Hambey Construction (which we have an annual contract with) had provided a quote as well and he would like to review the two before making a decision. He will return to the Commission for a bid award at a later time. No action was taken.

The Commission stood in recess until 10:00 a.m.

The Commission met with Sheriff Brad Cole for his quarterly report. Sheriff Cole presented his report. Discussion was held. No action was taken.


The Commission met with Sheriff Brad Cole for renewal of Tiger Commissary Services for the jail. This will be the final renewal with Tiger Commissary as their bid will be out next year. Sheriff Cole requested for this contract to be renewed for an additional year. Presiding Commissioner Phillips entertained a motion to approve renewing the contract with Tiger Commissary Services for an


additional year. Western Commissioner Bilyeu so moved. Eastern Commissioner Robertson seconded the motion.
