A quorum was established. Presiding Commissioner Phillips entertained a motion to approve the consent agenda, which included Christian County Commission's emergency agenda for today, May 1st, 2020 as published, Christian County Commission's regular session minutes dated April 30th, 2020 and Christian County Commission's closed session minutes per RSMo 610.021.2 (Real Estate) dated April 30th, 2020. There are no financials. Eastern Commissioner Robertson so moved. Western Commissioner Bilyeu seconded the motion.

The Commission met to amend their prior Stay at Home order. This order has several differences from previous orders including: limits on gatherings changed from 10 people to 20, businesses providing personal care of any kind are limited to 25% or less of their fire code capacity, businesses with less than 10,000 square feet that are engaged in retail sales to the public are limited to 25% of the building's maximum fire code occupancy, businesses with 10,000 square feet in size or larger are limited to no more than 10% of its' maximum fire code occupancy.


Western Commissioner Bilyeu questioned the ruling on houses of worship and funeral homes; in his personal opinion he would prefer to follow the language set out by the Governor's recommendation. Discussion was held and it was noted that the presented order had an error. Under items e and ee, Section E was referenced instead of Section F. The difference between these two sections allows houses of worship 50% of the building's maximum fire code occupancy rather than 25%. Presiding Commissioner Phillips noted the need for continued physical distancing practices for those in public places, saying he can't emphasize enough the importance of social distancing and the groups of smaller numbers. Western Commissioner Bilyeu added that he would likely vote no on the motion, but would give 100% support after the order is passed.

Presiding Commissioner Phillips entertained a motion to adopt order 05-01-2020-01 with the referenced change by means of roll call vote. Eastern Commissioner Robertson so moved. Presiding Commissioner Phillips seconded the motion.


Presiding Commissioner Phillips noted this emergency session meeting was for the purpose of extending the policy in place that has County buildings closed to the public except by appointment, but still operating to perform essential duties. The current policy expires on Monday, May 4th, 2020. Discussion was held. Presiding Commissioner Phillips entertained a motion to extend the current policy for an additional 30 days unless otherwise amended or revoked, to maintain social distancing and control occupancy within County Buildings. The policy will note two changes including: re-opening the "walk-up" window at the Collector's Office (located on the west side of the Historic Courthouse), and resuming operations at the Recycle Center to self-service drop offs. Eastern Commissioner Robertson so moved. Western Commissioner Bilyeu seconded the motion.


