A quorum was established. Presiding Commissioner Phillips entertained a motion to approve the consent agenda, which included Christian County Commission's agenda for today, May 18th, 2020 as published, Christian County Commission's regular session minutes dated May 14th, 2020, and Christian County Commission's closed session minutes dated May 14th, 2020. Western Commissioner Bilyeu so moved. Eastern Commissioner Robertson seconded the motion.

The Commission met with Purchasing Agent Krista Raleigh and County Clerk Kay Brown for a bid opening for sneeze guards. Two bids were received from Versa Products (\$200 per guard if 75+ ordered – 48x3 in size), and Election Systems & Software (\$110 per guard, no price break on quantity, 31.25x33 to 31.25x38 – adjustable). Clerk Brown will review the bids and return at a later date for a decision. No action was taken.


The Commission met to discuss transferring a County vehicle from the Commission to the Maintenance Department. The vehicle was obtained when the Assessor purchased new vehicles and transferred to the Commission as a spare. As the vehicle has not been used Presiding Commissioner Phillips suggested transferring the vehicle to another department in need. Discussion was held. Presiding Commissioner Phillips entertained a motion to transfer the vehicle from the Commission to the Maintenance Department. Eastern Commissioner Robertson so moved. Western Commissioner Bilyeu seconded the motion.
