A quorum was established. Presiding Commissioner Phillips entertained a motion to approve the consent agenda, which included Christian County Commission's agenda for today, June 25th, 2020 as published, Christian County Commission's regular session minutes dated June 22nd, 2020, Planning and Zoning Board Reappointments for Christie Hirsch, Vance Jenkins & Brenda Hobbs, and Christian County Library Board of Trustees Reappointment of Ken Barthelette. Eastern Commissioner Robertson so moved. Western Commissioner Bilyeu seconded the motion.

The Commission met with Resource Management Director Todd Wiesehan who is the CARES Act Committee Chairperson. Mr. Wiesehan presented five new applications which included the following offices/departments/entities: CCA-010 City of Highlandville (\$708.44), CCA-012 CC E911 (\$2,775.28), CCA-016 Recorder's Office (\$3,325.00), CCA-021 Circuit Court (\$1,709.64), and CCA-024 Emergency Management (\$4,267.73).

Western Commissioner Bilyeu inquired on requests by the schools and local organizations such as Show Me Christian County. Director Wiesehan replied yes, the committee met yesterday and discussed some of those requests. They are working toward assistance to small businesses; the goal is to allocate a specified amount. Auditor Dent added that small businesses have access to the paycheck protection program which has had three rounds, in addition they are able to request forgivable small business loans. Western Commissioner Bilyeu also inquired if the Health Department had requested funds. Director Wiesehan said they had; their request will be addressed at the next meeting.

Presiding Commissioner Phillips entertained a motion to approve the presented applications for fund reimbursement by the CARES Act Committee. Western Commissioner Bilyeu so moved. Eastern Commissioner Robertson seconded the motion.

The Commission met with Resource Management Director Todd Wiesehan for acceptance of roads within Southern View Hills development for perpetual maintenance on behalf of the Ozark Special Road District (OSRD). Director Wiesehan presented a right of way deed noted that the OSRD likes for the developer to hold onto the roads for 1 year prior to taking over maintenance. Mr. Turner the developer has met all specifications and the OSRD will now be maintaining the roads within the development. The roads will be accepted into County maintenance on behalf of the OSRD.

Presiding Commissioner Phillips entertained a motion to accept and execute the Right-of-Way Deed (accepting the roads within Southern View Hills development for perpetual maintenance on behalf of the OSRD). Eastern Commissioner Robertson so moved. Western Commissioner Bilyeu seconded the motion.
