A quorum was established. Presiding Commissioner Phillips entertained a motion to approve the consent agenda, which included Christian County Commission's agenda for today, August 24th, 2020 as published and Christian County Commission's regular session minutes dated August 20th, 2020. County Clerk Brown presented a financial for Know Ink (her previous sole source) with a quote for 30 additional poll pads with a quoted price of \$29,700.00 (no additional shipping etc. fees). Eastern Commissioner Robertson so moved. Western Commissioner Bilyeu seconded the motion.

The Commission met with Resource Management Director Todd Wiesehan who is the CARES Act Committee Chairperson. Mr. Wiesehan presented a summary of requests by entity (total amount requested and recommended) for the newest applications, as well as a Christian County CRF Dashboard (Coronavirus Relief Fund) print off.

The following applications were presented today: CCA-074 City of Nixa (\$45,832.00), CCA-075 City of Nixa (\$6,778.48), CCA-076 CC Sheriff's Office (\$6,847.00), CCA-026 Spokane R-VII (\$8,915.48 - 75/25% match w/ State), CCA-034 Nixa Public Schools (\$11,707.07 - 75/25% match w/ State), SBR-013 Professional Acct. & Tax Services (\$8,275.44), SBR-014 417 Restorations(\$3,636.18), and SBR-015 Dove Dental Group (\$10,000.00).

Presiding Commissioner Phillips entertained a motion to accept the recommendations by the Committee to find the listed applications approved: CCA-074, CCA-075, CCA-076, CCA-026 (\$6,686.61), CCA-034 (\$8,780.30), SBR-013 (\$4,111.15), SBR-014 (\$166.54), and SBR-015. Western Commissioner Bilyeu so moved. Eastern Commissioner Robertson seconded the motion.
