The Commission met with Highway Administrator Beadles for presentation of the 3rd quarter sales tax distributions. Discussion was held. No action was taken.

The Commission with EMA Director Phil Amtower for his quarterly report. Director Amtower presented his verbal report. Discussion was held. No action was taken.


The Commission met with Maintenance Supervisor Richard Teague for his quarterly report. Mr. Teague presented his report. Discussion was held. No action was taken.
