City Leaders & Special Road District Commissioners:

The Christian County Commission will be presenting, discussing and, if necessary, taking action to restructure the existing Sales Tax distribution program. This will take place during a regular session meeting on Thursday, October 15th at 9:00 a.m.

Our duty as a governmental body is to provide necessary services throughout the County, to the best of our ability, while abiding by the State Statutes. The County faces significant financial challenges in the near future as it pertains to roadway and bridge maintenance and, like many others, has limited resources to maintain the County's transportation system. The County can no longer afford to share a significant portion of our budget each year and is looking into possible solutions. We need to ensure that we are using funds earmarked for County use to the fullest extent possible.

In April of 1997, voters of Christian County approved a one-half cent sales tax for the purpose of funding road, bridge, maintenance and operations in Christian County. The ballot language did not include any mention of further distributions of this fund to Cities or Special Road Districts. However, the County has been voluntarily distributing a significant portion of these taxes annually to these groups through an application/agreement-based program. The Commission has decided to revisit this sharing program and reevaluate based on the current needs of the County.

The meeting will discuss the existing program, the future needs of the County and how to program can be restructured to allow for the programmed use of the funds.

Option 4: Dissolve program completely. Any local agency could still, thorugh IGA process, request cost-sharing for emergency projects.
