AN ORDER OF THE CHRISTIAN COUNTY COMMISSION ADOPTING THE CHRISTIAN COUNTY MULTI-JURISDICTIONAL HAZARD MITIGATION PLAN

WHEREAS the Christian County Commission recognizes the threat that natural hazards pose to people and property within the County; and

WHEREAS the Christian County Commission has participated in the preparation of a multi-hazard mitigation plan, hereby known as the Christian County Multi-Jurisdictional Hazard Mitigation Plan, hereafter referred to as the *Plan*, in accordance with the Disaster Mitigation Act of 2000; and

WHEREAS adoption by the Christian County Commission demonstrates their commitment to hazard mitigation and achieving the goals outlined in the *Plan*
