Recommendation of Award

Commissioners,

We are nearing the conclusion of the Request for Proposals process in the pursuit of Managed I.T. Services. The process began in August, with submission of legal notice in the paper, as well as selection of a Committee. The Committee consisted of myself, Prosecutor Amy Fite, Auditor Amy Dent, Human Resources Director Amber Bryant, and Resource Management Director Todd Wiesehan.

On September 2, 2020, the RFP was made available to all vendors, and subsequently four addendums were provided. All interested vendors were invited to attend site visits on September 22 and 23rd, and six firms took advantage of this opportunity.

Five proposals were received by the submission date of October 5th. These were distributed to all committee members for individual evaluation, and then all scores were compiled. The three highest-scoring firms were contacted and asked to give presentations, which were held on October 20th. After the conclusion of the presentations, the Committee discussed and finalized the rank of the firms.

The top two firms were contacted and asked to send their fee schedules and rates. The Auditor and I reviewed the fees, and affirmed the decision of the Committee.

The Committee recommends that award for Managed I.T. Services goes to PC Net, with a contract term of one year and the option of renewing the agreement for three additional one-year periods.

1. Title Program: Christian County Comprehensive Plan Update

2. Program Director: Brandon Jenson, AICP-C

3. Program Description:

The Southwest Missouri Council of Governments (SMCOG) is a regional planning commission based in Springfield, Missouri and serves a ten-county area. SMCOG is administered by the Center for Resource Planning and Management at Missouri State University. All staff are employees of the University but serving on behalf of SMCOG.

We have been a leader in planning efforts in Missouri, including transportation planning and economic development services, since our re-organization in 1989. We have made every effort to provide your community with an effective yet highly efficient project that we feel will more than meet your needs.

PROCESS & TENTATIVE TIMELINE

Month 1 (December 2020):

Staff orientation and project management meeting. SMCOG staff will meet with County staff to discuss project milestones, the makeup and desired structure of the planning committee, public engagement opportunities, and any primary issues the County wishes to be included in the planning process.

Months 2 -7 (January-June 2021):

Organization and Information Gathering. Staff will work with county staff and other local organizations to gather information pertinent to the planning effort. This includes previously completed plans and studies. Staff and student workers will collect demographic and socioeconomic data through public sources such as the Census Bureau. Staff will also conduct a current land use inventory of the unincorporated county, identifying each parcel's current use. A Comprehensive Planning Committee (CPC) composed of community volunteers will be established during this phase.

Online Webpage. SMCOG staff will develop an online webpage for use as a public platform for community members to follow the planning process.

Month 8 (July):

Orientation Meeting & Survey Preparation. This public meeting will inform the CPC and community members of the general purpose and process of planning. Staff will present relevant data collected to-date and finalize an online community survey to be distributed to residents. The survey will be set to go live in early October. Staff will create base maps to use throughout the planning process.

Month 9 (August):

Stakeholder Meeting. During a CPC meeting, identified stakeholders will present relevant information to frame future CPC conversations. Stakeholders may include the Sheriff, Emergency Manager, fire districts, library district, Show-Me Christian County, County Treasurer, County Collector, Health Department, County Assessor, County Road and Bridge, Presiding Commissioner, the Ozarks Transportation Organization, representatives from Christian County communities, and any others that may be identified.

Month 10 (September):

Survey Results & SWOT. The CPC will meet to review results from the community survey. SMCOG staff will facilitate a SWOT analysis to identify what the county's strengths and weaknesses are in order to begin identifying community goals.

Month 11 (October):

Goals & Objectives Meeting #1. The SMCOG staff will provide suggestions to the CPC for establishing goals and objectives based on survey results and gathered information.

Month 12 (November):

Goals & Objectives Meeting #2. This will provide an opportunity to continue discussion of any remaining topics not covered by the previous meeting and fine tune all the goals and objectives.

Month 13 (December):

Land Use Planning Meeting. Staff will facilitate this meeting to discuss possible future land use scenarios and build consensus among the CPC to develop a future land use map. Coordinating with incorporated communities regarding future land use projections will occur. The map will reflect land use goals discussed previously.

Month 14 (January 2022):

Public Open House, Goals and Objectives Prioritization. Staff will hold two public open houses, one on the east side of the county and one on the west side of the county. These open house events will focus on getting preliminary feedback and prioritization on identified goals and objectives. Staff will also develop an online survey option to gather priorities from those unable to attend an open house. Input received will help shape the narrative of the draft document.

Months 15-16 (February-March 2022):

Writing the Plan. The SMCOG staff will write the full and complete document. A draft will be provided to staff for initial review prior to the second open house.

Month 17 (April 2022):

Public Open House - Draft Plan Review. Comments will be received at the meeting and revisions made to the document based on public input.

Month 18 (May 2022):

Final Plan Presentation. The Plan will be presented to the Planning & Zoning Commission for their comments and adoption.

Next County Commission Meeting:

Adoption of Plan.

Ongoing Throughout Planning Process:

Public Engagement- In person. Staff will host/attend up to five (5) outreach events in addition to those outlined in the process above, with approval from the County. These events will be tailored to the intended audience and needed input. This may include targeted focus groups or popular local events and may assist in further developing the vision.
