A quorum was established. Presiding Commissioner Phillips entertained a motion to approve the consent agenda, which included Christian County Commission's agenda for today, January 7th, 2021 as published, Christian County Commission's regular session minutes dated December 21st, 2020 and Christian County Commission's closed session minutes per RSMo 610.021.17 (Auditor Communications). There are no financials. Western Commissioner Bilyeu so moved. Eastern Commissioner Morris seconded the motion.

The Commission met for presentation of the Christian County speed limit order. This is the third and final presentations of this order. This order will simply set regulatory speed limits on County roads between 25-45 mph: changeable in increments of 5 mph.

Presiding Commissioner Phillips entertained a motion to approve the Christian County speed limit order (No. 01-07-2021-01) as presented. Western Commissioner Bilyeu so moved. Eastern Commissioner Morris seconded the motion.

The Commission met with Auditor Amy Dent for the 2021 CARES Act and County Revenue budget hearing. Auditor Dent stated that the Commission had voted to approve County Operations (fund 101-170) on December 21st, and she ask that the vote be rescinded. That fund holds the CARES Act funds (line item 101-170-57581 2020 CARES Act Expenses), which were extended through June 30th, 2021. Discussion was held.

Presiding Commissioner Phillips entertained a motion to rescind the previous vote and approve the reallocated CARES funds in County Operations to include fund: 101-170 as presented by Auditor Dent. Eastern Commissioner Morris so moved. Western Commissioner Bilyeu seconded the motion.

The Commission met with Auditor Amy Dent for fund 550 (2020 CARES Act). As Auditor Dent previously stated that this account holds CARES Act funds, which were extended through June 30th, 2021. Discussion was held.

Presiding Commissioner Phillips entertained a motion to approve the reallocated fund 550 as presented by Auditor Dent. Eastern Commissioner Morris so moved. Western Commissioner Bilyeu seconded the motion.




