A quorum was established. Presiding Commissioner Phillips noted that Connell Insurance: Mid-Year Review would be removed from the agenda and rescheduled. Presiding Commissioner Phillips entertained a motion to approve the consent agenda, which included Christian County Commission's agenda for today, January 25th, 2021 as published, Certified Court Order No. 01-25-2021-01 and a financial from Maintenance for Cintas to do annual fire extinguisher inspections, emergency exit lights inspections, alarm checks and sprinkler checks. Cintas has extended their special pricing to all County Buildings based on the special pricing currently extended to the jail. Western Commissioner Bilyeu so moved. Eastern Commissioner Morris seconded the motion.

The Commission met to discuss the historic jail cell doors. Renovations are occurring on the 3rd floor of the Historic Courthouse where the original jail cells are. There are three (3) cell doors being preserved. Director Teague noted that the Sheriff's Office has requested one as well as the Juvenile Office and the Historical Society. Ms. Hires noted that one door could be retained by the Commission to be displayed in the Historic Courthouse.

Presiding Commissioner Phillips entertained a motion. Eastern Commissioner Morris moved to give one jail cell door to the Sheriff's Office, one to the Historic Society and to retain one for later use. Western Commissioner Bilyeu seconded the motion.

The Commission met with Sheriff Brad Cole for presentation of the Blueprint Grant. Sheriff Cole said the grant totals \$9,076.00 and is specifically for safety equipment for the roadways. This grant is fully funded and will cover new radar units.
