January 1 through January 26,

- Candidate filing for the Special Road Districts

- Prepared and submitted the 2021 Financial Statement for the year ending 12/31/2020
- Records reviewed and documented in preparation for destruction.

Payroll Clerk has processed the following:

- Invoiced grant reimbursement for Emergency Management, Sheriff, Juvenile and Prosecutor's Office for 11 individuals were also processed monthly.
- Monthly and Quarterly reports for the Collector and Assessor for the S.T.C. are being done.
- Minutes prepared and posted to the web site and filed.
- All year end reports such as W'2s, 941, SUTA, LAGERS and IRS were processed and submitted on time.
