A quorum was established. Presiding Commissioner Phillips entertained a motion to approve the consent agenda, which included the Christian County Commission's agenda for today, April 15th, 2021 as amended. The Commission met with Ashley Hannah, on behalf of Highway Administrator Miranda Beadles, for a bid opening for a pressure washer for the Common I Road District. Two bids were received from Hydro Engineering Inc. (\$5,793.26) and K O Manufacturing Inc. (\$5,995.00). The bids will be reviewed, and Administrator Beadles will return at a later date for recommendation of award. No action was taken.

The Commission met with Auditor Amy Dent and Human Resources Director Amber Bryant for a budget adjustment. As the Purchasing Agent position will be transferred from the Commission Office to Human Resources, and budget adjustment must be made to a lot Human Resources funding to hire and purchase needed equipment. Auditor Dent presented fun 101-240 (Human Resources), showing an increased difference of \$43,555.00 and fund 101-010 (County Commission) showing a decreased of \$43,555.00. Auditor Dent noted that fund 101-010 showed two options of adjustments; one allows salary for a part-time employee to be added and the other for a possible full-time employee to be added for additional flexibility in hours needed for a possible part-time employee. Discussion was held.

Presiding Commissioner Phillips entertained a motion to adjust the Commission budget (fund 101-010) to reflect the most flexibility for an additional employee. Eastern Commissioner Morris so moved. Western Commissioner Bilyeu seconded the motion.
