A quorum was established. Presiding Commissioner Phillips entertained a motion to approve the consent agenda, which included the Christian County Commission's agenda for today, April 29th, 2021 as posted, Christian County Commission's regular session minutes dated April 19th, 2021, Christian County Commission's closed session minutes per RSMo 610.021.3 (Personnel) dated April 19th, 2021, and an emergency purchase by Maintenance Director Teague for a card reader and mag lock for the jail waiting area; vendor will be Johnson Controls for a total amount of \$1,882.00. The Commission met with Human Resources Director Amber Bryant for a pandemic policy update. Director Bryant noted that in the first quarter of the year the County was fortunate to only see 6 positive employee COVID-19 cases; however, in the last three weeks there have been 5 positive employee cases. Director Bryant stated that leaving the pandemic policy in place is a best practice and today she would like to address an update to the travel policy. Instead of asking employees to quarantine upon returning from a hot zone, she suggested mandating they mask upon returning so they might return to work earlier. Many employees have been unable to take vacation time as the extra quarantine time is difficult to have and provides difficulty in staffing some offices/departments.

Presiding Commissioner Phillips entertained a motion update the pandemic policy as presented by Director Bryant. Western Commissioner Bilyeu so moved. Presiding Commissioner Phillips seconded the motion.
