2020 POLLING LOCATION CHANGES COMPLETED

- Rosedale 1A, moved to Nixa First Baptist Church. The Nixa First Baptist Church was successful in serving as a polling location for all the 2020 Elections.
- Lincoln 1, moved from Clever City Hall to Clever 1st Baptist Church due to renovation at City Hall. The Clever 1st Baptist Church has become a permanent home for the Lincoln #1 voters.
- Lincoln 2, moved to the Clever High School FEMA Shelter. The Clever High School FEMA Shelter was a success serving as a polling location for all the 2020 Election.
- Riverside (formerly Riverside 1&2) moved to the James River Church Youth Building.
 This facility was a success by providing ample interior and exterior space for the over 5,000 voters.

2021 SEARCH FOR POLLING LOCATIONS

After the November 3, 2020 Election, the search began to secure four new polling locations to serve the ever-growing number of registered voters in Christian County. I began seeking for four new polling locations to split the following precincts: Northview 1 and 2, Union Chapel 1, Union Chapel 2, and West Finley Precincts. Happy to say Mission Accomplished!!

2022 PROPOSED POLLING LOCATION CHANGES

Beginning January 1, 2022, 4 New Polling Locations will be created to house the growing number of voters in Christian County:

- Northview 1 and Northview 2 will be restructured to result in Northview 1A, Northview 1B, Northview 1C.
 - Northview 1A will be located at Highpoint Elementary School FEMA Gym
 - o Northview 1B will be located at Summit Intermediate School FEMA Gym
 - Northview 1C will be located at Nixa Junior High School
- Union Chapel #1 will be restructured to be Union Chapel 1A and Union Chapel 1B.
 - o Union Chapel 1A will be located at the Nixa Library.
 - Union Chapel 1B will be located at Northpoint Church in Nixa
- Union Chapel #2 will be restructured to be Union Chapel 2A and Union Chapel 2B.
 - Union Chapel 2A will remain at Inman School in Nixa
 - Union Chapel 2B will be located at Union Hill Church in Nixa
- West Finley will be restructured to be West Finley 1 and West Finley 2.
 West Finley 1 will remain at Ozark South Elementary School
 - West Finley 2 will be located at Life Point Church in Ozark

After the completion of these new polling locations, there will be a total of 29 polling locations to better serve the Christian County voters.

In 2021 the Nixa School District, James River Church of Ozark and St. Joseph's Church located in Billings, requested a contract with the County Clerk's Office to prohibit electioneering at their polling locations except within designated areas. These contracts have been in place for the past several years.

April 2018 = 50,855 active registered voters

April 2019 = 55,539 active registered voters (9% increase from 2018) Total Registered Voters 58,687

April 2020 = 53,972 active registered voters Total Registered Voters 60,512

April 2021 = 59,918 active registered voters (11% increase from 2020) Total Registered Voters 62,464
