A quorum was established. Presiding Commissioner Phillips noted one item to be removed from the agenda: Sheriff Cole: CARES. Presiding Commissioner Phillips entertained a motion to approve the consent agenda, which included the Christian County Commission's agenda for today, May 10th, 2021 as amended and Certified Court Order No. 05-10-2021-01. There are no minutes. Eastern Commissioner Morris so moved. Western Commissioner Bilyeu seconded the motion.

Aye: Bilyeu, Morris, Phillips. Nay: None. Absent: None. Abstain: None.

The Commission met with County Clerk Kay Brown for the 2021 precinct report. Clerk Brown discussed with the Commission the 2020 election year and what concerns were raised due to high voter turnout across the County. The Clerk's Office has been searching for polling locations and has found four (4) new locations to allow splitting some of the larger precincts. Effective January 2022 the following precincts will be split and realigned:

- Northview No. 1 (currently High Pointe Elementary School) and Northview No. 2 (currently Summit Intermediate School) will be redistricted to Northview 1A (High Pointe) 1B (Summit), and 1C (Nixa Junior High).
- Union Chapel No. 1 (currently Nixa Junior High School) to be redistricted to Union Chapel 1A (CC Library – Nixa Location) and 1B (North Point Church).
- Union Chapel No. 2 (currently Inman Intermediate School) to be redistricted to Union Chapel 2A (Inman Intermediate School) and 2B (Union Hill Church).
- West Finley (currently Ozark South Elementary School) to be redistricted to West Finley 1 (Ozark South) and 2 (Life Point Church).

These changes will give the County a total 29 polling locations.

Eastern Commissioner Morris inquired how many election judges will be needed to facilitate 4 additional locations. Clerk Brown noted that at least six (6) judges per location will be needed.

Discussion was held. No action was taken.

The meeting was adjourned at 9:09 a.m.




