A quorum was established. Chief Deputy Clerk Paula Brumfield appointed Eastern Commissioner Lynn Morris as Presiding Commissioner for today's meeting. Eastern Commissioner Morris entertained a motion to approve the consent agenda which includes the Christian County Commission agenda for today, July 08, 2021, as posted, and the Auditor's Monthly Report. There are no minutes or financials. Western Commissioner Bilyeu so moved. Eastern Commissioner Morris seconded the motion.

The Commission met with Maintenance Supervisor Richard Teague to discuss the historic square renovation project, specifically the sidewalk aspect of the project. Supervisor Teague noted that the City of Ozark reached out and offered to move the utility cabinets and help pay for the sidewalk stamping. This will move the sidewalk out 6ft from the bid documents, back to the originally planned placement. With this new information Supervisor Teague suggested piggybacking off the City's existing concrete bid instead of re-bidding this part of the project. The previous project did not receive any concrete bids, only the electrical component. Discussion was held. No action was taken.

The Commission met to award Davis Electric for the historic square renovation project on the electrical scope of the project. The City's bid that the County plans to piggyback off did not include an electrical aspect.

Eastern Commissioner Morris entertained a motion to approve the bid award to Davis Electric, contingent upon the full project with the City of Ozark. Western Commissioner Bilyeu so moved. Eastern Commissioner Morris seconded the motion.

The Commission met with Andrea Sitzes the President and CEO of Show Me Christian County for a quarterly report. Ms. Sitzes reviewed staffing reports and business retention and expansion reports for April, May, and June, touching on the highlights of each month's reports. Discussion was held. No action was taken.

The Commission met with Jeremy Parsons with the City of Ozark to discuss partnering with the County to complete the sidewalk project. Mr. Parsons noted that since all bids for the City's project had been received and came in under budget, the City has additional funding that could help the County complete the sidewalks around the square and move the utility cabinets. the City would need easements on the northeast and southwest corners of the square to cut across and get access to the stormwater. Mr. Parsons added that pricing for the paving would be from Capital Paving (formally Journagan), he would be able to plug in the quantities needed to create a projected cost estimate that would allow for the IGA between the two parties. Discussion was held. No action was taken.
