




# Low density residential uses with minimal agriculture uses surround this property.



# LOCATION: 2690 Terrell Valley Dr., Republic, MO



# **PROJECT DESCRIPTION:**

The applicant proposes the change in zoning classification for an 11.74 +/- acre parcel from A-1 to A-R in order that it can be lawfully subdivided for an additional parcel and residence. Both future parcels would be 5+ acres in size.



# PLANNING / LAND USE ANALYSIS:

# Land Use Plan:

The Christian County Generalized Future Land Use Map projects this area to be agricultural use with dispersed residences for the foreseeable future.

# Compatibility:

Future lot size will be similar to surrounding properties. Additionally, the original intent of this area was to be a platted residential subdivision.

# Connectivity:

This change would not significantly impact any vehicular or pedestrian connectivity.



# **PROJECT/SITE ANALYSIS:**

If the applicant's request for zoning change is approved , any development which occurs would be required to be in compliance with the County's Development Regulations.

# Landscaping and Buffering:

No provisions for landscaping or buffering have been offered or will be required at this time.

# Building Design:

One of the 5+ parcels to be created already contains a house and accessory building. The other 5+ acre parcel to be created is currently vacant ground and is proposed to be used for a single-family dwelling.

# Access:

The property has an existing, shared, access to Terrell Valley Drive.

*Utility Services:* Existing on site.



# ENVIRONMENTAL ANALYSIS:

Stormwater Impact:

None is anticipated as a result of this change. The amount of undeveloped acreage allows for normal infiltration of rainwater.

*Groundwater Impact:* None anticipated.

Floodplain/Sinkhole Impacts:

No mapped sinkholes or areas of floodplain exist on the parcel.



# STAFF COMMENTS:

Approval of this application will allow for the applicant to achieve their goal of splitting their 11.74-acre property into two 5+ acre parcels to build an additional home for their family.

# **RECOMMENDATIONS:**

The Planning and Zoning Commission reviewed this application at its July 19, 2021, meeting and provided opportunity for public comment. The Commission voted unanimously, with one abstention, to recommend approval of this rezoning request.

# ORDER OF THE CHRISTIAN COUNTY COMMISSION OZARK, MISSOURI

DATE ISSUED: August 2, 2021

SUBJECT: CASE NUMBER 2021-0191

### TEXT:

CLIFFORD & MARY ALLEN petition the Christian County Commission to rezone a 11.74 acre tract of land from A-1 (Agriculture District) to A-R (AGRICULTURAL RESIDENCE) in order to lawfully permit land use compatible with surrounding parcels and be reflected as such on the Christian County Zoning Map 2690 TERRELL VALLEY DR, REPUBLIC, Missouri, located within Parcel 06-0.8-33-0-0-5.012 which is legally described as follows:

## TRACT IC:

A tract of land being a part of the Northwest Quarter (NW¼) of Section Thirty-three (33), Township Twenty-eight (28) North, Range Twenty-three (23) West, the boundary being more particularly described as follows: Commencing at an aluminum monument at the Northwest corner of said Northwest Quarter (NW¼); thence South 88°30'36" East, along the North line of said Northwest Quarter (NW¼), 1,340.33 feet; thence south 01°30'56" West, 46.33 feet to an iron pin on the South right-of-way line of County Line road (as it now exists); thence South 01°30'56" West, 509.94 feet to an iron pin for the point of beginning; thence South 88°55'50" East, 865.77 feet to an iron pin on the West right-of-way line of Terrell Valley Boulevard (as it now exists); thence South 01°37'43" West, along said right-of-way line, 591.03 feet to an iron pin; thence North 88°55'50" West, 864.61 feet to an iron pin; thence North 01°30'56" East, 591.02 feet to the point of beginning, all in CHRISTIAN County, Missouri.

The Christian County Planning and Zoning Commission did, during public hearing on July 19, 2021 review this request and hear public comment. A motion to recommend approval of this change passed by a unanimous vote.

Now, therefore, after additional review of this case and having heard additional public comment the Christian County Commission did this day, upon a motion by Commissioner Bilyeu, seconded by Commissioner Morris, vote unanimously to approve this request.
