Chairman Ted Nichols said the purpose of this Salary Commission meeting is to set the salary for the offices that will be elected in 2020. The offices for election are as follows: Western Commissioner, Eastern Commissioner, Assessor, Coroner, Public Administrator, Sheriff and Treasurer. The Assessor will begin the 2020 term September 1, 2021. Chairman Nichols called for a motion to bring the all the offices to the same salary for the next term beginning January 1, 2021.

MOTION/VOTE: APPROVE THE SALARY SCHEDULE AT 105% OF THE MAXIMUM ALLOWABLE COMPENSATION PER STATUTE.

County Auditor Amy Dent made the motion to continue the annual salary schedule at 105% of the maximum allowable compensation per statute. The motion was seconded by Presiding Commissioner Ralph Phillips.

Treasurer Karen Matthews said she does not like voting to give herself a pay increase but we had always kept the salaries the same and if we didn't vote to increase the salary we would get so far behind that we would never be able to get caught up. We are at the bottom of the pay scale for all the first class counties.

Chairman Nichols said no one likes voting for raises but the Legislature will not make any changes to the salary schedule. During the 10 plus years of being a second class county almost no raises were given to the elected officials.

REPORT OF CHRISTIAN COUNTY SALARY COMMISSION

The salary commission for the County of Christian, State of Missouri, hereby certifies that pursuant to Section 50.333, RSMO., it met on the 25th day of October 2021 to establish compensation for the county offices of Presiding Commissioner, Auditor, County Clerk, County Recorder of Deeds, and Collector of Revenue to be paid to such officers, holding such office for the new term of office beginning on or after January 1, 2023.

The salary commission reports that the salary of each office holder for the term of office beginning during the calendar year 2023 shall continue to receive one hundred five percent (105%) of the maximum allowable compensation as first classification of non-chartered county per county assessed valuation as allowed by law 50.343. The salary of the office holder shall be tied to schedule as set out in statue 50.343.1 RSMO and the salary shall be 105% of the maximum allowable compensation and as set forth by the set schedules outlined in statue.

The salary commission authorize that each elected official's salary shall be adjusted as a cost-of-living component annually by the same percent as the percentage increase, if any, awarded to all county employees for that same year, as allowed per 50.333.12, RSMO. The motion passed 13 yes and 0 no by members present.

The salary commission for Christian County hereby certifies that it has met pursuant to law to establish compensation for county officers to be paid to such officers during the next term of office for the officers affected. The salary commission reports that there shall continue at five percent county officer's salaries, set at 105 percent of the "maximum allowable compensation".

Chairman Ted Nichols said the purpose of this Salary Commission meeting is to set the salary for the offices that will be elected in 2022. The offices for election are as follows: Presiding Commissioner, Recorder of Deeds, County Clerk, Sheriff, Collector and Auditor. Chairman Nichols said all the offices are set at the same rate so a vote to increase is no longer needed for those entering a new term January 1, 2023.

Prosecuting Attorney Amy Fite, commented on the new legislation 57.317 RSMO for the Sheriff and when it would begin either January 1, 2022, or January 1, 2025. Sheriff Cole referred to a letter from the County Counselor that was received by the Sheriff and the County Clerk. In the letter, the County Counselor approved the salary increase to begin January 1, 2022. The letter also states the County Commission would make the decision when the salary increase would begin.

Chairman Nichols wanted the record to show that the Prosecuting Attorney and Sheriff will continue to serve on the Salary Commission, even though their salaries are set by different statutes than the rest of the Salary Commission.
