The Christian County Commission and its staff has performed a review of your proposal to consider the degree to which it may be an eligible use of ARPA funds based upon the guidance made available by the U.S. Treasury Dept. Additionally, the Commission has given consideration to various other factors, including but not limited to, the proposal's ability to present a clear plan to accomplish a sustainable project or outcome which will be of commensurate value to the citizens of Christian County for the investment proposed.

Notes:

Eligible under reporting category 6.1 - Provision of Government Services. The final rule offers a standard allowance for revenue loss of \$10 million, allowing recipients to select between a standard amount of revenue loss or complete a full revenue loss calculation. Recipients that select the standard allowance may use that amount – in many cases their full award – for government services, with streamlined reporting requirements.

Funding for the design, permitting and construction of three (3) County bridges: Green Bridge, Hawkins Bridge & Red Bridge.
