A quorum was established with all Commissioners present. Presiding Commissioner Phillips entertained a motion to approve the consent agenda, which included the Christian County Commission's agenda for today, August 9, 2022 which was posted in accordance to statue, approving funding for minor repairs from flooding in the Sheriff's Office flooring and approval of Court Order 08-09-2022-01 (Road and Bridge Sales Tax) in the amount of \$548,699.33.

Commissioner Morris so moved. Commissioner Bilyeu seconded the motion.

The Commission met Auditor Amy Dent, Judge Johnson, Barb Stillings, Perry Barnes and Terry Conner for discussion and approval of the proposed 2023 budget. The Commission voted to approve the budget the Circuit Courts 1 and 2 (14.47% increase) and Consolidated Courts (26.98% increase) and the proposed 28% increase for the Juvenile was postponed. Commissioner Bilyeu moved and Commissioner Morris seconded the motion to approve.

County Clerk Kay Brown submitted the August 2, 2022, certified election results. No action needed.

The Commission met with EMA Director Phil Amtower, Ozark Fire Chief Metheny and Nixa Chief Walles to discuss a county wide burn order. Options were discussed. **No action needed**.

The Commission unanimously approved the appointment of Resource Management Director Todd Wiesehan to be the County's representative on the Show Me Christian County (Economic Development Organization) Board. Commissioner Bilyeu moved and Commissioner Morris seconded the motion to approve.

The Commission met with Richard Teague, Maintenance Director to discuss the continuing issue with sewer system in the jail. The disposal system is inadequate and causing sewage to back up increasing possible health issues. David Lundstrom, Great River Engineering provided a summary of the cost to resolve the issue would be at the cost of approximately \$500,000.00. The initial phase would require an engineering study. Commissioner Bilyeu moved and Commissioner Morris seconded the motion to approve the study and by Great River Engineering.

A discussion was held regarding a request from Centurytel/Brightspeeds for a letter of support for their applications for grants monies through the Missouri Broadband Infrastructure Grant Program. The Commission is currently conducting a feasibility study and awaiting the results before any decisions are made regarding these types of requests. **No action taken!**

The Commission met to discuss rescinding the Circuit Clerk's use of the County's tax identification number. It was, once again, discovered during the Counties external financial audit that the County's tax identification number was used in violation of state statue and without the Counties knowledge. Commissioner Morris made a motioned to rescind the use by the Clerk of the Courts. Commissioner Bilyeu seconded the motion.
