A quorum was established at 9:00 a.m.

Presiding Commissioner Phillips entertained a motion to approve the consent agenda, which includes approval of today's agenda, approval of regular session minutes from August 23, 2022, closed session minutes from August 26, 2022 – per RSMo 610.021.1, regarding litigation, and closed session minutes from August 10, 2022, per RSM. 610.021.3, regarding personnel.

Eastern Commissioner Morris made the motion to approve. Western Commissioner Bilyeu seconded the motion.

The Commissioners met with presenter Miranda Beadles, Highway Administrator, regarding a Missouri Department of Conservation grant agreement for the Woods Fork Road, in the amount of \$160,582.50. Discussion was held.

Presiding Commissioner Phillips entertained the motion to approve the grant as presented, Western Commissioner Bilyeu made the motion, Eastern Commissioner Morris seconded the motion.

The commissioners met with Todd Wiesehan regarding a Regional Broadband Initiative update and approval of cost share. Discussion was held regarding the selection of a Request for Qualifications from The Broadband Group. They have submitted a cost share agreement in the amount of \$291,860.00, plus travel expenses approved at cost. Christian County's portion, calculated at 21.13% of the population, is \$61,670.00, plus potential travel costs, to be paid in monthly installments. Auditor Dent confirmed that ARPA funds are available for broadband related expenses.

Presiding Commissioner Phillips entertained a motion to continue with the representation currently on the Regional Broadband Initiative board and to confirm commitment of financial support. Western Commissioner Bilyeu so moved; Eastern Commissioner Morris seconded the motion.

The Commissioners met with presenter Todd Wiesehan regarding an update on the development of the property located at 2701 W Jackson Street in Ozark, and the request for approval of an addendum to the agreement with Great River Engineering for redesign of storm water, sewer, retention, basins, and redesigns in the amount of \$19,860.00.
