ADDENDUM TO REGIONAL BROADBAND INITIATIVE PARTICIPATION AGREEMENT

THIS ADDENDUM ("Addendum") is made and entered into on this ____ day of _____, 20____ (the "Effective Date"), by and between the parties defined below (collectively referred to as "Parties").

WITNESSETH:

WHEREAS, the Parties entered into a Regional Broadband Initiative Participation Agreement ("Agreement") for the purpose of combining efforts and funds to improve access to broadband high-speed internet throughout the region served by the Parties; and

WHEREAS, the Parties now enter into this Addendum to the Agreement for the purpose of specifying the costs owed by each respective party based upon their respective percentage share allocations set forth in the Agreement; and

NOW THEREFORE,

1. **Parties.** The Parties to this Addendum are as follows:

- 1.1 Christian County Missouri, by and through the Commissions of Christian County Missouri ("Christian County")
- 1.2 City of Nixa, Missouri ("Nixa")
- 1.3 City of Ozark, Missouri ("Ozark")
- 1.4 City of Republic, Missouri ("Republic")
- 1.5 City of Strafford, Missouri ("Strafford")
- 1.6 City of Willard, Missouri ("Willard")
- 1.7 Greene County Missouri, by and through the Commissioners of Greene County, Missouri ("Greene County")

2. **Shared Cost Obligations of the Parties.** Pursuant to paragraphs 2.1 and 6.1 of the Agreement, the Parties agreed to share the cost of a broadband feasibility analysis ("Analysis") based upon their respective pro rata percentage shares as set forth in Exhibit A to the Agreement. Per the authority delegated to the Regional Broadband Initiative Board ("RBI Board") in paragraph 4.5.1 of the Agreement, the RBI Board has elected to engage the services of The Broadband Group ("Vendor") to perform the Analysis, the costs of which are set forth in the Vendor's proposal, incorporated herein and attached as "Exhibit 1."

The cost shares owed by each of the Parties for the Analysis are as follows:

PARTY	PERCENTAGE SHARE	AMOUNT OWED (of \$316,860)
Greene County	46.9% (42.42% + 4.48%)	\$148,607.34
Christian County	21.13% (17.26% + 3.87%)	\$66,952.52
Ozark	10.39%	\$32,921.75
Nixa	10.62%	\$33,650.53
Republic	7.61%	\$24,113.05
Willard	2.21%	\$7,002.61
Strafford	1.14%	\$3,612.20

3. **Payment.** Within fifteen (15) days of execution of this Addendum, each party hereto shall remit payment of its respective amount owed, as set forth above in paragraph 2, to Greene County, as the appointed custodian of records for the RBI Board. Greene County shall then be responsible for timely remitting those funds on behalf of the RBI Board to Vendor for its work in performing the Analysis, as such funds become due and owing.










