The initial agreement that all of our partners and the county approved did not account for a potential travel expense associated with this. That total maximum is called out as 25,000, and that amount is to be prorated in the same manner as the rest of the agreement. There is a Difference of 5,282.48. As we are paying 21.13% of the cost of the entire project. We are looking for the Commission to sign off on the revised addendum.
