We had three proposals, Darrell Mrotec Construction, Kenny Cox LLC, and Rob Muilenberg Excavating. All the proposals were reviewed. The recommendation is to award all three vendors.

received a quote from Symbiont Services in the amount of \$7,562 for the HVAC replacement. The Auditor has approved the funds.

The Commissioners met with presenter Joan Doss regarding the Planning and Zoning Staff Report. Case Number 2022-0294. The applicant is Brady and Bonnie Start. The applicant proposes the change in zoning classification of 15 acres from A-1 to RR-1. So that it can be lawfully utilized for single-family residential use acceptable within the RR-1 Rural-Residential District. The application notes that the property owner would like to subdivide the property into two 4-acre tracts and one 7-acre tract. The subject property is currently vacant, with a small sinkhole/pond on the southern portion and a grove of trees on the northern portion. One well would be shared, and individual septic systems. All the comments at the P&Z commission were noted with questions regarding groundwater and wells. The Commission voted unanimously to recommend approval of this rezoning request.
