The Commissioners met with presenter Kim Hopkins-Will regarding Award: Summit Mailing & Shipping Services State of Missouri Contract #CC21938009 – Quadiant Postage Meter Equipment Effective June 30, 2024, the USPS is decertifying all postage meters that use IBI technology and adopting a new technology IMI standard for postage evidence systems. Purchasing Agent Kim Hopkins-Will put together

a committee to review the State of Missouri contract options for postage meters. The committee reviewed Pitney Bowes and Quadient postage equipment; both are in the state of Mo. Contracts. We have two meters right now, a small and larger one. The smaller one is located at the Resource Planning Building and is on its last leg. Our recommendation is to lease the small IX-1 for the Resource Planning building now and to purchase/lease the IX-DS equipment at a later date to be determined but before compliance is mandatory. We ask that you award the equipment for Quadient, who uses the State of Missouri contract.
