The Commissioners met regarding the Forest Service/1908 Act/Secure Rural Schools County Elections. We have till next week on the 25th to notify the federal government of our intent to accept the grant money. We have two choices: receiving SRS full payment of \$71,700.00 or a 25% 7-year rolling average of \$63,800.00. Ms. Dent recommended taking the 25% rolling average, which is 63,800.00.

Presiding Commissioner Morris entertained a motion, and Western Commissioner Bilyeu made the motion that we receive the full payment amount and distribute it at 75/25 % as we have in previous years. Eastern Commissioner Jackson seconded the motion. Lynn will vote in support of the other two Commissioner and the rural schools.
