Presiding Commissioner Morris entertained a motion to approve the consent agenda, which includes approval of today's agenda, and approval of regular session minutes from July 25<sup>th</sup>, 2023.

Presiding Commissioner Morris entertained a motion to approve the consent agenda as stated. Western Commissioner Bilyeu made the motion; Eastern Commissioner Jackson seconded the motion.

The Commissioners met with presenter Jillian Johnson regarding the Historic River District Proposal. The Historic River District would like to propose putting some polywood furniture on the gazebo and also putting a memorial plaque on the back of the rocking chair as a memorial for Debbie Spencer. Jillian spoke with Richard, and he will help assemble these for us. We will have four rocking chairs and two round tables with four chairs. The next goal is to repurpose some of the picnic tables. Debbie entered a grant for the AARP, and the goal was to bring multi-generations down to the Gazebo. We would like to have binoculars for bird watching and outdoor board games.

The Commissioners met with presenter Kim Hopkins-Will and Richard Teague regarding the Emergency Procurement – 202 Building – Air Compressor. We had an air compressor go down for the 202 building. Richard figured out how much the materials would cost if he and his crew did it, and it would be more than the quote that we got from Jamerson. This was \$3,800.00, and we got a new air compressor from them. Kim wanted to make sure that the Commissioners knew that she has the responsibility, along with you, to

declare emergencies. Kim can only declare emergencies with your authority. We have it in our policy book that Kim has been given that authority. Kim always contacts the Presiding Commissioner.

The Commissioners met with presenter Kim Hopkins-Will regarding the Award: 2023—0016 — County Wide Office Supplies. Our current office supply vendor could not keep to their 3% increase; it was actually going to be a 22% increase in office supplies. Kim bid this out. We sent out 42 bid requests, and we received five bids back. Kim would like to award this to both Quill and Staples. Staples owns Quill.

The Commissioners met with presenter Joan Doss regarding the Rezoning case 2023-0192 (Summer Start Division LLC). The applicant is Summer Start Division LLC (Melinda Love). The current Zoning is for A-R Agricultural residences. The applicant proposes a change in zoning classification for an approximate 17.2-acre area parcel from A-R to R-2 in order that it can be lawfully developed into a single-family or duplex residential subdivision. There are no mapped floodplain or sinkhole areas on the subject property. Staff are aware of a cave system in the vicinity, but it is not noted on the preliminary plat nor county maps. No members of the public voiced comments or concerns at the planning commission meeting. Planning and Zoning reviewed this application at its July 17, 2023, meeting, and the Commission voted unanimously to recommend approval of this rezoning request.
