Presiding Commissioner Morris entertained a motion to approve the consent agenda, which includes approval of today's agenda, approval of regular session minutes from August 15th, 2023, and approval of work-study session minutes from August 15th.

General Levy – The current levy is 0.0446. Ms. Dent's calculations were .0480, which would increase the levy to .0032, giving us about 57,000 plus. That would go to retire the debt on the circuit court building. That averages about .70 per person. The Handcock Amendment mandates this.

Presiding Commissioner Morris entertained a motion. Eastern Commissioner Jackson made a motion that we leave the property tax levy at .0446. Western Commissioner Bilyeu seconded the motion that we keep the Levy at .0446.
