Presiding Commissioner Morris entertained a motion to approve the consent agenda, which includes approval of today's agenda, approval of regular session minutes from October 24, 2023, and approval of closed session per RSMo 610.021.3 (Personnel) from October 24, 2023.

Presiding Commissioner Morris entertained a motion to approve the consent agenda as stated. Eastern Commissioner Jackson made the motion; Western Commissioner Bilyeu seconded the motion.

The Commissioners met with presenter Paula Brumfield regarding the Swearing-in of the LERF Board Reappointments. Brian Lindsey & Michael Burch were reappointed and sworn in by County Clerk Paula Brumfield.

The Commissioners met with the presenter Sheriff Cole regarding the Fremont Hills MOU. The Fremont Hill MOU was discussed and presented.

Presiding Commissioner Morris entertained a motion to approve the MOU concerning Fremont Hills. Western Commissioner Bilyeu made the motion; Eastern Commissioner Jackson seconded the motion.

The Commissioners met with presenter Croley/HR regarding 2024 Employee Health Benefits. Trevor Croley and Michelle Brown presented the renewal of the county's Health Benefits and options for 2024. A

discussion was held. Cox and United Health Care are the two options for 2024.

The Commissioners met with presenter Todd Wiesehan regarding the Resource Management 3Q Report. The quarterly report was presented, and a discussion was held.

Bob Robino asked two questions. The Commission answered, and Miranda will look into this.

The Commissioners met to discuss the 2024 Chamber Membership. Presiding Commissioner Morris asked Eastern Commissioner Jackson to look at Ozark and Nixa membership fees. Eastern Commissioner Jackson agreed to look at these.

The Commissioners met with presenter Kim Hopkins-Will regarding the Contract Renewal: Cintas Uniform and Supply Rental. This contract was bid in 2021 and began January 1, 2022. It provided for two one-year renewals. This is the final renewal. This is for the rental of uniforms and miscellaneous supplies (mats, mops, disposable towels, etc.) for the Highway Department, Recycling Center, and Maintenance Department. Ms. Hopkins-Will recommends the Commission award the contract renewal to Cintas for a final year.

Presiding Commissioner Morris entertained a motion to approve the renewal. Western Commissioner Bilyeu made the motion; Eastern Commissioner Jackson seconded the motion.

The Highway Department requested a Single Feasible Source for a Hiniker Snowplow to Bus Andrews. The Hiniker Snowplow fell under #1 of our policy as a single distributor. We currently standardize with Hiniker plows and have the parts and supplies in stock for future maintenance. Kim's recommendation is to approve to Bus Andrews, the distributor for Hiniker.

Presiding Commissioner Morris entertained a motion to approve. Eastern Commissioner Jackson made the motion to approve the purchase of the snowplow; Western Commissioner Bilyeu seconded the motion.

Kim's recommendation is to approve to Bus Andrews, the distributor for SaltDogg.


