Presiding Commissioner Morris entertained a motion to approve the consent agenda, which included Christian County Commission's agenda for today, January 10, 2024, as posted. The Commission met with Auditor Amy Dent for the 2024 Appropriation order.

Auditor Dent noted that there was a need for a budget adjustment for both Common 1 and Common 2 road department budgets (231 & 232) due to purchases made in 2023 that were not delivered or invoiced yet, so they have carryover funds into the 2024 budget year. Highway Administrator Beadles noted that the carryover is for projects that are yet to be completed (Holder Rd. traffic study, Old Prospect widening project), and radios & lights on the new trucks.

Presiding Commissioner Morris entertained a motion to approve budget adjustment for Common 1 and Common 2 as presented. Western Commissioner Bilyeu so moved. Eastern Commissioner Jackson seconded the motion.

Auditor Dent noted that the appropriation order was prepared by County Clerk Paula Brumfield and approving it appropriates the funds for all budgets that were previously approved by the Commission.




