Shop Where You Live Campaign Update: Rachel Campbell & Stevie Barfoot with Show Me Christian County updated the group on "Shop Where You Live". This campaign encourages residents to shop in Christian County to bring sales tax revenue in. They had a soft launch back in November 2023 and met with local Christian County Chambers, the Historic River District and other officials. The next step will be a work session and standing meetings. Show Me Christian County is taking the lead on this and campaign packages to hand out are being put together. This campaign will need funding for marketing purposes and the Chambers and Cities have agreed to participate. Education is needed as to why it is important to shop local.

Marriage Proclamation: A Proclamation was presented by Rev Jerry Angelo & his wife Kate Angelo to the Commission that will acknowledge that February 7th-14th will be proclaimed as Marriage Week. This is the second year in a row that Christian County has recognized this Proclamation and help to support the movement to promote marriage and family.
