Items to be removed from the consent agenda:

Presiding Commissioner Morris entertained a motion to approve the consent agenda, which included Christian County Commission's agenda for today, April 16, 2024, as posted, and Christian County Commission's regular session minutes dated April 11, 2024. There are no financials to address. Eastern Commissioner Jackson so moved. Western Commissioner Bilyeu seconded the motion.

The Commission met to honor the Chadwick High School Girls Cross Country team with a proclamation as they are the 2023 1A State Champions. This is Chadwick's first girls' cross-country team, and this is Chadwick's first State championship for Girls' Cross Country. Eastern Commissioner Jackson read the proclamation aloud and presented each member with a laminated copy. Members of the team include Gretchen House, Emily Landry, Macy Landry, Raeleigh Little, Alexia Loveland and Madeline Sallee. They were coached by Jenny Gardner and Jessi Little. No action was taken.

The Commission met to present the Christian County Proclamation as it is National County Government Month. Presiding Commissioner Morris read the proclamation aloud. No action was taken.

The Commission met with Maintenance Supervisor Richard Teague to discuss the donation of excess gloves & hand sanitizer to the Chadwick School District. The excess supply came from what the County obtained during the COVID-19 Pandemic. The items planned to be donated are not items the County can utilize. The school reached out stating they could utilize them. Discussion was held.

They hope to start moving items on Friday if approved. Discussion was held. No action was taken. This agreement will be re-visited at Thursday's Commission meeting.

The Commission met with Highway Administrator Beadles regarding right of way easements for the Green Bridge Project. Eastern Commissioner Jackson stated that the final property owner signed an agreement so that the project can move forward.

Presiding Commissioner Morris entertained a motion to approve the warranty deed and temporary construction easement as presented. Eastern Commissioner Jackson so moved. Western Commissioner Bilyeu seconded the motion.
