Recommendation of award is for Streetwise, Inc. as they were they lower bid and can complete project in spring of 2025.



The Commission met with Sheryl Blakeley with Verizon Wireless for a discussion on security and options for phones. Discussion was held. No action was taken.


The Commission had a brief discussion concerning communications.

The meeting was adjourned at 10:08 a.m.




