Presiding Commissioner Morris entertained a motion to approve the consent agenda, which included Christian County Commission's agenda for today, July 09, 2024, as posted, Christian County Commission's regular session minutes dated June 27, 2024; Christian County Commission's regular session minutes dated June 28, 2024; Christian County Commission's regular session minutes dated July 02, 2024, and one financial, Certified Court Order no. 07-09-2024-01. The Commission met with Highway Administrator Miranda Beadles for an update on the reuse of Green Bridge. Discussion was held.

Administrator Beadles stated that as a back-up option, the County could move the bridge and place it on the new 40-acre campus and incorporate it into a walking/biking trail for the community to utilize. Administrator Beadles requested the Commission to vote between the two options prior to award of construction for Green Bridge, as this would instate an alternate in the bid.
