Presiding Commissioner Morris entertained a motion to approve the consent agenda, which included Christian County Commission's agenda for today, August 01, 2024, as posted, and Christian County Commission's regular session minutes dated July 30, 2024. The Commission met with County Counselor Austin Fax to review a new order regarding the senior citizen tax freeze. Counselor Fax read order no. 08-01-2024-01, discussing Senate Bill 756 which amends Senate Bill 190; the largest amendment being the removal of the social security requirement to be eligible for the tax freeze. Senate Bill 756 simplified the qualifications to citizens of 62 years old, is an owner of record of a homestead, and is liable for the payment of real property taxes on such homestead. Discussion was held.

Presiding Commissioner Morris entertained a motion to adopt order no. 08-01-2024-01, replacing the previously adopted order no. 12-12-2023-02 with the discussed changes. Eastern Commissioner Jackson so moved. Western Commissioner Bilyeu seconded the motion.
