vehicles protected. The Christian County Sheriff's Office reserves the right to inspect the prospective awarded bidder's facility before award. If, for any reason, the Sheriff's Office finds that the facility cannot provide adequate protection for the vehicles, this may result in disqualification.

The following are questions submitted by a prospective bidder and the official response from Christian County.

Questions from Blink Marketing, Inc.

Question 1: What is the completion timeline for the work? **Answer 1:** Due to the importance of these vehicles being on the road, time is of the essence. Our current contract completion time is approximately half a day for the cars and a full day for the SUVs/Trucks.

Question 2: What is the service location where all the vehicles will be available to be treated?

Answer 2: Christian County does not have a location conducive to this work. The Sheriff's Office anticipates transporting the vehicles to the **awarded bidder's location** for the service. At the bottom of the Events Detail page, it reads, "Note: Prospective bidders should be located within a **25-mile radius** of the Christian County Sheriff's Office." Question 4: Are there only 8 vehicles to be treated for the entire contract term?

Answer 4: No, there are eight (8) vehicle types/models with possible multiple quantities of each throughout the year. The intent of this bid is to provide a one-year contract with options to renew to wrap the Sheriff's Office vehicles with the specifications provided.
