The Commission met with Maintenance Supervisor Richard Teague for his 3rd Quarter report. Discussion was held, no action was taken.

The Commission met with Purchasing Manager Kim Hopkins-Will for contract renewal for uniform supply rental services to Cintas Corporation. This contract will renew effective January 01, 2025, and will terminate on December 31, 2025.

Clerk Brumfield stated that since her office has taken over the agenda, she would like to see a program implemented where agenda requests will be submitted online with all documentation and set a deadline to simplify the process. Employee Services Director Amber Bryant spoke briefly about sunshine requests, specifically creating a process to simplify how to submit and answer sunshine requests, noting that requests received outside of this process will not be recognized as official sunshine requests. They plan to return on December 19th with a final process and will request approval.

The Commission met with Planning Administrator Scott Hayes for a rezoning hearing. Administrator Hayes presented case no. 2024-0277, the applicant being Ryann's Hangar LLC. The property is currently zoned as R-1 (Suburban Residence District), rezoning request is for C-2 (General Commercial District). This item was heard by the planning and zoning commission on November 18th, the case failed to pass a motion, so a special meeting was held on November 25th and a motion passed to deny this rezoning request. Staff recommended the County Commission remand this item back to the planning and zoning commission to consider this new information and determine its effect, if any, on this request then forward a new recommendation to the County Commission. Discussion was held.
