### SETTLEMENT AGREEMENT AND RELEASE

THIS SETTLEMENT AGREEMENT AND RELEASE, hereinafter referred to as the Release, is entered into by and between Claimants Christian County, Missouri, and Emery Sapp and Sons, Inc. ("Claimants") and Respondent Great River Association, Inc. (hereinafter "Respondent").

### **RECITALS**

A. WHEREAS, Respondent contracted with Claimant Christian County on May 5, 2021 to provide services with respect to the design and construction of Green Bridge, Bridge No. 24900031 replacement, "The Project".

B. WHEREAS, in the course of its work Respondent provided incorrect beam seat elevations at the top of the caps for intermediate bents 2 and 3 as noted on the construction plans, sheets S9 and S11, the "Oversight".

C. WHEREAS, to address the issues arising out of the Oversight, Emery Sapp provided services and materials and corrected the problem, the "Remediation", and made a claim for payment. "The Claim".

D. WHEREAS, all work to remediate the Oversight has now been completed. Claimant Emery Sapp has documented costs of \$101,395.93, the "Remediation Costs".

E. WHEREAS, all parties wish to resolve and extinguish any and all claims arising out of the Oversight and the Remediation, Respondent has agreed to reimburse Emery Sapp for the Remediation Costs in exchange for a release by Claimants.

### COVENANTS AND AGREEMENTS

NOW, THEREFORE, for and in consideration of the foregoing, the mutual promises and covenants and agreements herein contained, the Parties hereto covenant and agree as follows:

- Payment. Payment shall be made to Emery Sapp & Sons in an amount totaling \$101.395.93 for settlement of the claim which has been asserted. The payments shall be made as follows:
  - a. Respondent's insurer. Lexington Insurance Company, will issue a check made payable to Emery Sapp & Sons, Inc., in the amount of \$51,983.93;
  - b. Respondent, Great River Association, Inc., will issue a check made payable to Emery Sapp & Sons, Inc., in the amount of \$49,412;
  - c. These payments shall total \$101,395.93 and be made within thirty (30) days of execution of this Agreement.
- <u>Release</u>. For the sole consideration of the settlement payment, Claimants, and on behalf of all predecessors, successors, affiliates, attorneys, agents and assigns, hereby release, acquit, and forever discharge Respondent, and its insurer Lexington Insurance Company, and all respective agents, representatives, employees, officers, insurers, attorneys.

shareholders, subsidiaries, affiliates, servants, successors, assigns, and heirs from any and all claims against Respondent associated with the Oversight, including but not limited to claims in law or in equity, asserted or assertable, known or unknown, ascertained or unascertained, accrued or unaccrued, direct, indirect, and/or consequential that Claimants ever had, now has, or which hereafter can, shall, or may have that were caused by, resulting from, arising out of, related to, and/or involving the Oversight and the Remediation. This release does not include any claims in law or in equity, asserted or assertable, known or unknown, ascertained or unascertained, accrued or unaccrued, direct, indirect, and/or consequential that Claimants ever had, now has, or which hereafter can, shall, or may have that were caused by, resulting from, arising out of, related to, and/or involving the Oversight and the Remediation. This release does not include any claims in law or in equity, asserted or assertable, known or unknown, ascertained or unascertained, accrued or unaccrued, direct, indirect, and/or consequential that Claimants ever had, now has, or which hereafter can, shall, or may have that were caused by, resulting from, arising out of, related to, and/or involving Change Order #3 Plan revisions sent by email on 05/06/2025, including the following work:

Removal of Bents 1 and 4, including temporary support of the superstructure Construct new Bents 1 and 4 Modifications to Bents 2 and 3 Additions of expansion joints and structural steel diaphragms

Nor does this Release include any other claims in law or in equity related to the Project that were not associated with or as a result of the Oversight.

- No Admission of Liability. It is understood and agreed that this is the compromise of a doubtful and disputed Claim, made for the purpose of preventing ongoing and potentially costly litigations, and that nothing in this Release shall be construed as any admission of liability on the part of Respondent.
- 4. Entire Agreement and Severability. This Release may not be modified, altered, amended, or otherwise changed except upon written consent by each of the Parties hereto. Should any provision of this Release be held invalid or unenforceable by a court of competent jurisdiction, the Parties agree that the remaining provisions shall remain in full force and effect.
- 5. <u>Governing Law.</u> This Release shall be governed by, and construed in accordance with, the laws of the State of Missouri.



# Supplement to weekly progress update June 26, 2025

This information covers activity which has taken place since the Monday agenda deadline

## Clinic Interior

It's been a good first part of this week.

- Bathroom floors and walls are now tiled and grouted.
- Overhead lighting fixtures have been wired and dropped into the ceiling grid.
- HVAC diffusers are connected and dropped into place.
- Cabinetry has been delivered and workers are completing installation.

## Electric Installation

There is no news to report regarding an install date for electric. We are, however, doing anything we can to be ready on our end. This includes:

- Identifying a short term generator option and the cost if this measure is needed.
- Assuring that areas where installation will occur are at the proper grade.
- Making sure the concrete transformer pedestal pad outside the building is ready and waiting.

## Natural Gas Installation

Late last week I informed the Commission about the grade issue on the western side of the building and the fact that we need to build the area up with fill in order that utilities can be buried at the proper depth. Great River is working with ESS to quantify the amount of material and labor to build up the berm we need. Ultimately, this is part of the work we had cut out of the bid initially, hoping to defer cost to a later phase.

## Fiber Installation

Bill Rawlings, John Beadles and I met with a representatives from Liberty Connect on Monday 6/23 to discuss bringing fiber from Jackson St. up to the building. We were informed that the route they will use is coming in from 25<sup>th</sup> St. which is the opposite of what Liberty Electric plans call for. The County will be required to provide the trenching and conduit from the ROW at 25<sup>th</sup> to the building.

## **Overall Site Development**

ESS has continued to finish up details at the site this week:

- Finished concrete flatwork behind the seating area of the detention basin.
- Completed several missing sections of sidewalk.
- Cleaned up areas of excess gravel in preparation for seeding.

# Change Orders and Possible Added Costs on the Horizon

Additional Earth Moving – Once GRE is able to quantify the amount of material and ESS arrives at a cost to build up the berm we need I will need to present a change order to the Commission. The goal is to have this available for review next week.

Generator rental – I've requested quotes from multiple rental companies in the area. Several companies including General Rental and Equipment Rentals do not have access to units with the capacity we need but have given recommendations.

Sunbelt Rentals - 1600 Chestnut Expy (417) 799-5195 (see attached quote).

United Rental - 2700 E. Kearney (417) 292-1190 (still awaiting quote).

Herc Rentals – 1907 E Bergman (417) 357-5849 (still awaiting quote).

Central Power Systems – Tim Schultz (417) 840-5713 (awaiting call back)

Our architecture firm GHN also has their electric specialist working to locate an option for us as well.

*Fiber Install* - At this time we are waiting on further detail from Liberty in order to get a quote from the trenching contractor which the County has an annual with. If all goes well, we will have the same contractor doing both the electric and fiber trenching at the same time which would minimize mobilization cost. An amount for trenching work was already included in the Requisition for the electric install. Its possible this amount may cover the trenching for both electric and fiber. Once we have the specs needed to get a firm bid we'll know where that stands.

Lots of activity taking place on Wed. 6/25. Cabinets and toilets being installed. Final connections made from HVAC ducts to diffusers.
