The Commission met briefly for communications.

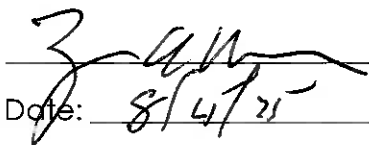

The meeting was adjourned at 10:40 a.m.



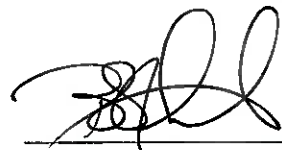
