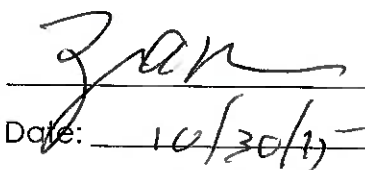
The Commission met briefly for communications. Bob Titus and Burt Whaley presented the County with a commemorative flag for the 250th Anniversary of the United States.
