Items to be removed from the consent agenda:

Presiding Commissioner Morris entertained a motion to approve the consent agenda, which included Christian County Commission's agenda for today November 06, 2025, as posted; there are no minutes or financials to address. Western Commissioner Williams so moved. Eastern Commissioner Jackson seconded the motion.

The Commission met with Employee Services Director Amber Bryant and Toni Giurbino regarding employee health insurance. Director Bryant noted that when the County went out to bid earlier this year, United Healthcare (2025 insurance provider) presented a renewal with a 49% increase based on the County's high utilization of almost 140%. Director Bryant noted that the preference of utilization is under 100% to be deemed more insurable. After receiving the renewal from United Healthcare and a few declines to quote, Director Bryant investigated other insurance options including becoming self-insured. Director Bryant suggested becoming self-insured as the County's best financial option and the best option for employees. The County will still cover 100% of an employees' premium (base plan), which will increase from \$543.72 a month to \$850.00. Employees will be covered in the Cigna network, able to utilize CoxHealth or Mercy. Additionally, the County will be moving from Guardian to Principal for ancillary benefits. Discussion was held.

Presiding Commissioner Morris entertained a motion to approve the County becoming self-insured utilizing 90 Degrees TPA/Cigna Healthcare for 2026. Western Commissioner Williams so moved. Eastern Commissioner Jackson seconded the motion.

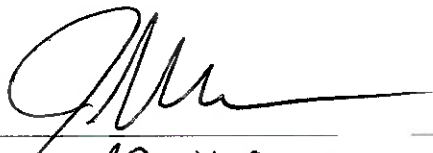

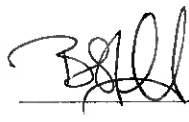
